Characteristics:

Degrasan F100 is a liquid, neutral product based on aldehyde. It is used for room sanitation in the Food-, Cosmetic- and Pharmaceutical Industry. Degrasan F100 can be used in the Food Industry (dairies, beverage, meat- and tinned food industry) as well as in the cosmetic and pharmaceutical industry for reduction of air-infection in production-, filling- and packing sections. By atomizing F 100 you will achieve reduction of germs on all surfaces within production rooms, moreover you will considerably reduce the contact of germs in the air.

Application / Dosage:

Concentration: 2 – 3 %

F 100 is atomized by respective equipment. Due to toxicologic aspects, this procedure may be applied in absence of personnel only.

The daily appliance is done over night, after cleaning and disinfection of the production line.

In order to obtain an efficient concentration in the air, it is necessary to atomize 10 – 20 ml of a 2 – 3 % solution per each m³. Any ventilation has to be stopped during the complete treatment time.

Atomizing Time: Depends on the size of equipment and seize of the room. Approx. 30 – 60 minutes.

Reaction Time: Minimum 2 – 4 hours. It is recommended to extend the reaction time until short period before starting production. A sufficient ventilation has to be granted before entering the sanitized rooms. Please make sure that the formaldehyde content in the air does not exceed 1.2 mg/m³.

When applied according to a.m. instructions, F 100 guarantees killing of gram-positive and gram-negative bacteria as well as yeasts and molds on surfaces of different material (wood, plastics, metal).

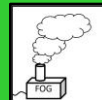
